Wrong Ownership Rules

Summary

- Horrible things happen when a society gets its ownership rules wrong. (e.g., Slavery).
- Americans/Westerners have gotten rules of ownership and restriction of non-matter wrong.
- The so called western Intellectual Property Rights regime is a big mistake.
- Americans/Westerners are a self-oriented (individual-orientged). Easterners are society oriented.
- Americans/Westerners are imposing these mistaken views on the East.
- The Western Self-Toxication model is spreading through the world in large part through IPR model.

Mis Understanding of Non-Matter

Summary

- Intellectual Property is the westerner's extension of capitalism into realm of non-matter.
- In contrast to matter that exists in singular, Non-matter exists in multiples and can therefore not be owned.
- Non-Matter (multi-existential) Examples: Software, Knowledge, Process, Music, Film, Books.
- Matter(single-existential) Examples: Pen, Spoon, House, Land, Goat, Spectrum.
- Economic justifications of IPR are bogus. Look at Linux vs Microsoft.

Cure

Summary

- The East needs to reject IPR and formulate its own independent model for bringing non-matter into the society.
- IPR is fundamentally wrong. Can not be re-adjusted. Must be rejected.
- Full rejection by the East. Iranian style. Start with new vocabulary.
- Software is a special form of non-matter that best illustrates how non-matter prospers when not owned. Build on that.
- Revisit the economic model. Example, Software into Service. <http://www.neda.com/>
- Beyond the free software movement. Towards formulation of free software national policy.
- Beyond national policy for Libre Software. Notional policy for all Libre non-matter (Pharmaceuticals, Music, Film, ...)

Matter vs Non-Matter.

Definition of Matter: That which exists in nature in singular.

Definition of Non-Matter: That which exists in nature in plural.

Examples of Matter: A Pen, A Pencil, A Car, A Tree, A Dog, Spectrum, Cocaine

Examples of Non-Matter: Knowledge, Processes, Ideas, Software, Recorded Music, Content of a Book, Porn, Pfizer Viagra

Generally Speaking, Matter: Is touchable. Is not recordable. Is not transmittable.

Generally Speaking, Non-Matter: Is not touchable. Is recordable. Is transmittable.

Ownership of Matter: Real Property. Thou shall not steal (in all religions)

Ownership of Non-Matter: Libre. Copyright and Patent are against nature. (so called Intellectual Property)

Mixed Up Matter.

Primarily Non-Matter – Software

The CD (media) containing Libre Software is matter.

Libre Software is non-matter.

The License that goes with Proprietary Software is not part of nature. Current western law has resulted into the concept of CD, Software and License as Mixed Up Matter.

Mixed Up Matter.

Primarily Non-Matter – Pharmaceuticals

Sildenafil citrate is matter.

The knowledge of its formula “C₂₂H₃₀N₆O₄S” is non-matter.

Pfizer's Viagra revolves around a patent and a trademark. Not part of nature. Mixed Up Matter. Today when you buy Viagra, you are primarily getting non-matter.

Millions are dying in Africa and India, even though the matter for their medicine costs almost nothing. That non-matter (subject to western patent rules) is killing millions.

Each drug advertisement that you see in American TV (and only in American TV) is for a patent and a trademark.

Mixed Up Matter.

Primarily Matter.

A car is made of matter.

Some processes (non-matter) used in making a car may be patented.

Today when you buy a car, the patent costs are included.

Properties of Non-Matter.

The fundamental difference between Matter and Non-Matter is that Matter exists in singular and non-matter exists in multiple.

Knowledge, ideas, software, recorded music exist in multiples. Copying does no harm to the original.

You can't touch it, you can't feel it.

Because matter exists in singular, it is natural for it to have an owner.

Private and Public Non-Matter.

Because non-matter exists in multiples it is not natural for it to have an owner. But non-matter can be private non-matter or public non-matter. Private non-matter is secret. Public non-matter is knowledge. Neither is ownable.

Matter is ownable. A House is Private Property. A National Park is public property.

- Music
- Movies

Software: A Special Form of Non-Matter.

- Utilitarian / Useful
- Lends itself well to collaborative development
- Accumulates development (cumulative)
- Free Software/Tools facilitate development of more Software
